

REGISTRATION APPLICATION REQUIREMENTS

- 1. Service/Breeders Certificate signed by owner/manager of sire. (If PHANZ stallion this must have been returned on a PHANZ Breeding Report. Stallion owner must be a financial member at time of service.)
- Set of four (4) photographs this application must be accompanied by four (4) photographs either via email or on quality photo paper, showing the horse directly from each side, front and rear. Direct shots must be made: angle shots will not be accepted. Regular sized photographs are preferred. Do not trim photographs. If the horse has minimal markings which need to be verified for registration, please provide additional close up photographs. It may be necessary to wet or shave the area to verify pink skin size. The registration certificate will be issued in accordance with the photographs submitted.
- 3. This application must be signed by all owners, if joint owners both nominees. Owners must sign the applications.
- 4. All filly foals born on and from the 01/08/2005 must be DNA typed prior to be used for breeding.
- 5. All Stallion Classifications will not be finalized until after receipt of completed PHANZ Veterinary Certificate and the results of the DNA typing and 5 Panel test results being received by the PHANZ office. Stallions MUST not be used for breeding purposes prior to completion of the Classification by the PHANZ office.
- 6. Imported Horses: copy of current registration Certificate and copies of required genetic testing results.
- 7. Artificial insemination is permitted provided that: (a) Stallion owners wishing to participate in breeding by artificial insemination must notify the Association of their intention to do so at least 30 days prior to the first collection of semen each breeding season. The Association has the right to send its representatives to inspect the premises and practices of any person or breeding establishment using artificial insemination, and no person shall refuse, upon reasonable request, full access to the said premises. (b) The breeding certificate must show that artificial insemination was used. (c) An A.I. Technician holding a Department of Agriculture Insemination Certificate for horses it to be given the same status as a veterinarian for AI purposes provided that they are qualified relevant to state laws. (c) Collection and shipment of CHILLED semen can be carried out by a Veterinarian, AI Technician or PHANZ member. The transport of semen is permissible only under strict guidelines as set out by the PHANZ. These guidelines are available on request.
- 8. Frozen/imported chilled semen is permissible under the following guidelines: (1) Foreign stallions must be registered and classified with the appropriate breed registry of their resident country. (2) Authorization from foreign owners to have an appointed representative or agent in New Zealand to sign all relevant documentation. (3) All horses conceived by frozen / imported chilled semen are required to be DNA tested prior to registration for parentage verification. Both the resulting foal and the dam are to be DNA tested. (4) Foreign quarter horses and thoroughbred stallions for these purposes will be allowable when they follow PHANZ registration procedures. (5) Stallion must test N/N for HYPP and HERDA n/Hrd or n/n, GBED n/Gb or n/n, PSSM n/P1 or n/n, MH n/MH orn/n. Results must be put on the progenies file.
 - PHANZ allows frozen/imported chilled to be used for an indefinite period from the date of the last collection, under the following conditions: (1) An agent must be appointed. (2) There can be only one agent recognized for frozen/imported chilled semen of a nominated stallion. (3) A breeding return must be submitted each year. This report must be furnished whether the stallion is deceased, gelded or infertile.

UNATURAL MARKINGS:

Any horse which is found to have unnatural markings will be rejected for registration and the owner may be barred from the PHANZ. The PHANZ shall have the option of sending a PHANZ representative to collect hair samples and/or biopsies (by a licensed Veterinarian) as a precedent right to registration for the horse to remain registered.

The registration will not be processed until all paperwork and fees are received and are in order.
